## Legal Analysis of Each

- First Option To Be Dropped
  - MAD
    - Majority vote well sort of.....
    - Not District Wide
    - Must define the project
    - Variable assessments based on proximity to project
    - Weighted Vote
      - Businesses
      - Residences
    - Probable legal challenge




## Legal Analysis of Each

- Parcel Tax
  - Requires 66 2/3 vote
  - \$5 \$10 million per year
  - Probable limited term 4 to 5 years
- Bond
  - Requires 55% vote
  - \$400 to \$500 million

#### Science Behind the Task

- Survey Bond and Parcel Tax
  - District Expense
  - Development of the Questions
  - How to test the threshold
- 55% v 66 and 2/3%
- BIG DIFFERENCE !
- BIG SURPRISE !
