Option I: AB 806 and the Never-Ending Fight for a Rational Approach to the 50% Law

Eagle/Berryessa/Tahoe

By the time this session is presented, one of two things will be true—either AB 806 will have passed out of the Assembly Appropriations Committee and be headed to the Assembly Floor for a vote, or it will have become yet another unsuccessful attempt to finally deal rationally with the effects of the 50% law on Districts.

Either way, one thing is clear—more education is needed about the impact of arbitrarily sequestering half your districts budget on just two things, a narrow definition of faculty salaries and benefits, and the other half on everything else. Two stalwarts in the fight for a rational approach to "50%" are here to provide an overview of where we now stand with legislation to finally address this road block to student success.

Option II: Collective Bargaining and the Slow Recovery Shasta

Between the cuts in state funding in recent years, the focus on student success, and the expectations of constituents now that Proposition 30 has passed, community colleges are faced with significant challenges, even as the economy and state funding improves. The pressure is on districts to now reverse prior concessions and restore programs and services in order to meet the competing demands of the various stakeholder groups.

Along with federal health care and pension reform these are the issues that are at the forefront during collective bargaining. This session will focus on strategies and tools to help districts address barriers to successful negotiations, and will also explain what happens if negotiations were to dissolve into impasse, factfinding, and beyond.

Option I: FRAUD! A Case Study

The anatomy of a fraud case can be incredibly revealing. Not only in terms of the crime itself, but in what it reveals about safeguards and internal controls that can mean the difference between smooth sailing and having your office tied up indefinitely with investigations and legal proceedings.

San Mateo CCD had to deal firsthand with this development, and much can be learned from their experience with a purchasing fraud case. In this case study presentation, panelists will focus on how the fraud was uncovered, the resulting forensic audit, and the subsequent work with the DA to successfully resolve the incident. Panelists will explore the changes to the districts internal controls that resulted and how your district can adapt them to your own processes.

Option I: GO Bond Reauthorization[™] and NMTC Eagle/Berryessa/Tahoe

Many K-14 districts have voter-approved GO bonds which cannot be sold due to decreased assessed valuations and Prop 39 tax rate restrictions. A new product, GO Reauthorization BondsTM, allows districts to sell these bonds and continue their construction and maintenance projects. In addition, this financing method avoids costly capital appreciation bonds and is compliant with newly proposed AB 182 bond restrictions. Although just recently developed, GO Reauthorization BondsTM were approved in twelve districts last November.
