### **CCC Systemwide Initiatives**

- Developed from Student Success Task Force
- Increase access and success for courses and transfer degrees via online education.
- Primary focus:
  - Strengthen support and guidance to students
  - Set and report local success goals
  - Provide focused professional development and sharing of best practices

### **CCC Systemwide Initiatives**

- Student Success Task Force Recommendation
  7.1 and 7.2 identified need for stronger State
  Chancellor's Office that:
  - Coordinates development of indicator and goalsetting framework for colleges
  - Identifies effective practices
  - Provides technical assistance and professional development

# **Education Planning Initiative**

- Improve support and guidance for students
- Recommendation 2.2
  - Students develop an education plan and recognized the need for new modes of service delivery
- Recommendation 2.3
  - Called for centralized and integrated technology to better guide students

# **Education Planning Initiative**

The Vision and Goal:

Structured pathways that support planning/progress

- Directed—Learn to navigate using tools
- Nurtured—High touch, my college cares
- Focused—My goal is connected to my career
- Engaged—Connected to resources/opportunities

### EPI Toolsets – Key Features

Create sustainable support with integrated statewide tools:

Student Portal: Personalization, messaging

Career Exploration: Cultivate compelling goals

Orientation: On-ramp to success

• Education Planning: Tied to timely Degree Audit

Early Alert: Awareness and collaboration

Back-end: eTranscripts, Curriculum

### EPI Timeline through 2018

- Working Together: Spring 2016
  - Complete 15 pilots and implement improvements
- Moving Forward: Summer 2016
  - Next round with career tools available statewide
- Making a Difference: Winter 2017 Summer 2018
  - Continue implementations -> target 60 colleges
  - Evaluate improvements from baselines

#### EPI: College/District Implementation

#### **Lessons Learned**

- Free beer or a free puppy?
- Local integration work is significant
- Requires good local data curriculum/catalog
- Not a technology project business process
- Functional leadership is crucial

#### EPI: College/District Implementation

#### **Lessons Learned**

- Similar to ERP projects
  - Training, practice, training, practice
  - Business process changes are difficult
  - Dedicated time from counseling faculty
  - Need for counseling faculty leadership
- Change or TTWWADI?

- Cooperation/collaboration
- Sharing technology solutions
- Sharing best practices
- Governance keep good people engaged
- Participate in EPT-DAS/EPISC/SSPSC

# Online Education Initiative Goals:

- Significantly increase transfer to 4-year institutions;
- Increase completion by providing access to quality online courses and support services
- Create economies of scale in resource and technology acquisition (\$7,000,000 yearly savings on CMS infrastructure alone).

# Common Course Management System Adoption: Canvas

- <u>Canvas</u> adoption is ahead of schedule!
- 61% of colleges have committed since July 2015.
- 24/7 Help Desk
- Migration and faculty resources have been developed (Creative Commons)
- Professional development for online pedagogy as well as Canvas (Creative Commons)

# Common Course Management System Adoption: Canvas


- Canvas will be used by all classes across the system
- Use is not limited to online only blended, hybrid, flipped, traditional
- Enormous implications for data analytic use
  - EPI includes Starfish early alert software
  - Basic research on learning and teaching
  - CCC research and reporting

# Original Purpose of the Exchange

- Students will seamlessly enroll in courses, as needed, at other CCCs.
- Levels enrollments in high demand or difficult to fill courses.
- Access to resources for colleges and students
- Improve completion rates across the state

# **Exchange Opportunities**

- Creation of a system wide registration system
- Consortium-based degree patterns that increase access to a variety of degrees across the state
- Ability to offer capstone courses more frequently by combining enrollments across colleges
- Expand to CTE Degrees
- Accommodate the needs of rapidly increasing populations (i.e. "free" college)
