

- Separate legal entities from District
- Provide supportive services/programs to District
  - Title 5, Section 59259
- District has limited control over auxiliary organizations

- Student association or organization activities
- · Bookstores; food and campus services
- Loans, scholarships, grants
- · Workshops, institutes, conferences, federal programs
- Facilities and equipment
- · Alumni activities
- · Supplementary health services
- Gifts, bequests, devises, endowments, and trusts
- Public relations programs

### **Independent or Auxiliary**



- Independent
  - Exactly that
  - District no authority over decisions
  - District can enter into contracts with an independent foundation
- Auxiliary
  - District CEO responsible to ascertain propriety of all expenditures
  - Foundation board holds decision-making authority
  - Ultimate remedy is for District to revoke organization's status as an auxiliary

- Purposes
  - Auxiliary Promote or assist District
- · Receipt of gifts, funds, property
  - Auxiliary Use for benefit of District
- Permissible functions
- Audit requirements
  - Auxiliary Provide audit report to District

### **Differences Between Independent and Auxiliary Organizations**



- Board of Directors
  - Auxiliary approved by District's Board
- · CPA and attorney services
- Responsibility for expenditures
  - District must ensure auxiliary expenses are proper
- · Reimbursement of costs
  - Auxiliary reimburse District for services

  - Chancellor's Office must approve
- Auxiliary organization must update governing documents
  - Master Agreement
  - District Board approves

### **Fundraising**



- Permissible function
- Auxiliary organizations may conduct fundraising for:
  - Scholarships
  - Capital projects
  - Grants for campus needs
- Includes events, donations, gifts, raffles
- · Auxiliary responsible for expenses

- Foundation may seek out and accept gifts and donations
  - For District's and students' benefit
- Donations in exchange for value
  - Quid pro quo donations
- · In-kind donations
- Auxiliary organization provides donation acknowledgments when needed

### **Support for Bond Campaigns**



- Districts may not urge support or defeat of ballot measures
- But Auxiliary organizations may:
  - Elect to be subject to IRC §501(h)
  - Use % of Exempt Purposes Expenditures
    - 20% of first \$500,000
    - 15% of next \$500,000
    - 10% of next \$500,000
    - 5% over that amount, up to a \$1M maximum

### Case Study

### Raffles



- Districts prohibited from holding raffles
- But auxiliary organizations may be eligible to hold raffles
  - Must be nonprofit organization
  - Exempt from taxation by State
  - In existence at least 1 year before raffle
- Must keep 90% of raffle receipts

### Raffles



- DOJ registration and reporting requirements
  - Do not apply to 501(c)(3) entities
  - But likely apply to auxiliary organizations
- Must comply with annual filing requirements for raffles
