

	Session Title	Session Description
1	Ethics and the Public Contracting Process; Developing and Implementation of a Code of Conduct	A discussion of ethical considerations and establishing a code of conduct for public contracting. Initial group discussion of circumstances leading to potential ethics violations (meals/entertainment, vendor selection, self-dealing, disclosure/reporting requirements) is contemplated. That discussion is followed by a presentation of applicable legal standards. Finally, the workshop will revert back to a participatory discussion of the potential elements and scope of a code of conduct along with development of an outline of a code of ethics.
2	Negotiations Fail--Facing Fact Finding	This is a panel session that will address the process for fact finding, how to prepare for fact finding, and the outcome. It will include a panel from three community colleges that have gone through fact finding and hopefully, Ron Bennett, from School Services.
3	Budget Impact on our Students: Winning!	In light of increased budget cuts, many colleges are evaluating their Drop for Non-Payment processes, requiring student payment commitment in order to hold a seat. Learn how AVC offers a low cost option for holding classes even available to students who wait until the last minute to apply for financial aid. Paying attention to the bottom line and promoting accessâ€œ a win-win!
4	Finding Balance Between Work and Home	For working adults, striking a balance between work and home is always a challenge. This session will show participants how to find a balance point at the end of each workday so they can fully focus on life after-work...no more 'blackberry orphans' and neglected spouses. Learn practical steps to clear your mind at the end of each day so you can relax and find daily balance in life.
5	Cloud Computing for CBOs - Exploring Legal and Risk Management Issues	This session will identify and discuss the legal issues associated with outsourcing information technology services and provide suggestions for how to manage the risks associated with cloud computing.
6	California Supreme Court Eliminates Redevelopment Agencies: What does that mean for Community College Districts?	Will my CCD still receive redevelopment pass-through payments? How will they be calculated? And who will oversee this process? This presentation focuses on the impact of AB1x26 and the creation and composition of the Oversight Boards, including roles, key responsibilities, asset disposal, and the financial impacts of the oversight Boardâ€™s decisions on CCDs. We will also discuss the next steps CCDs can take to accelerate their redevelopment money, including leveraging redevelopment dollars for bond issuances.
7	MYSPACE OR WORKSPACE: KEEPING UP WITH ELECTRONIC TECHNOLOGY PRIVACY IN THE WORKPLACE	Every day, courts scramble to apply existing legal precedent to the latest and the greatest technology, and wrestle with the dividing line between what is intended to be public versus the truly private. This session will highlight the most recent developments on such topics as social media use in the workplace, the latest modes of â€œelectronic surveillance,â€ computer forensics investigations and the growing impact of electronic technology on the public workspace.

8	Changes to Power Purchase Agreement Tax Benefits & Incentives	When the calendar turned from 2011 to 2012 there were a number of changes to the Federal Government's Solar Tax Incentives. This session will explain those changes and answer questions about the budget impacts of monetizing these tax credits.
9	Bid Protest: Favoritism Most Foul	In these tough economic times in the construction industry, you can expect more bidders on your projects and fierce scrutiny by bidders attacking each others' bids in hopes of getting the contract. This session will provide you with expertise relating to the important new case that provides ammunition for bid protesters if the awarding agency doesn't fully understand the legal concepts of responsiveness and responsibility.
10	Governance Issues for Educational Entities	This workshop is designed to assist community college business officers address issues that come up in Board meetings and when dealing with senior administrators and staff. Topics covered include: Brown Act basics; basic parliamentary procedural issues; the power of one Board member; proper roles for Board and Staff; and what to do when a Board member is accused of misconduct.
11	Stop Payment Notice â€“ An Update	This workshop will focus on important substantive changes to the stop notice laws, soon to be called â€œstop payment noticeâ€ laws. We will discuss the basic laws governing stop payment notices, including required notices, priorities, and claims for enforcement, and will also include a discussion regarding prompt pay statutes. This workshop will provide practical advice to community colleges regarding the new changes to waiver and release forms, the impact of changes to statutory terminology, and options for handling stop payment notice claims.
12	Contracting for Goods and Services in Todayâ€™s Volatile Economy	The ever changing economy and hardships and budget cuts facing community college districts are forcing districts to rethink how they contract for goods and services. This session will analyze options available to districts for contracting for goods and services to assist in saving costs and risks, including when it may be useful for your district to pursue alternatives to competitive bidding. This session will also discuss the basics of contract law, what are the essential elements of a contract and what provisions you should look for in a contract for goods or services.
13	Energy Conservation Projects - Best Practices	At every community college energy costs are a valid concern. Whether or not to consider energy conservation upgrades is no longer the question. The question is, when do they make sense and how do you ensure you are making a wise investment? This panel will explore real-world implementation of conservation strategies that take pressure off the budget as well as proven steps to guarantee project success.
14	A Brown Act Update	The Brown Act is invoked more and more frequently as a basis to challenge District action, and especially employment decisions. The right path can be hard to find. We will go over the ways in which the Brown Act intersects with public employment issues, including closed sessions, administrative decisions, litigation and settlements.

15	How to Utilize Energy Code 4217 for Campus Improvements	With the impact of the economy most colleges are suffering from time constraints and budget issues for campus improvements. This session will explain Energy Code 4217, and the benefits of utilizing this procurement method. We will review a case study from Chaffey College and reveal benefits and lessons learned they have received from Energy Code 4217 through multiple projects.
16	Bonds and Parcel Taxes: November 2012 and Beyond?	The panel will discuss the current trends among Community College Districts as we head toward the cut-off date for the November 2012 ballot. Those trends include what to do if a district is too late for November 2012; how to properly sequence bond and parcel tax elections; and how to use a 55% Proposition 39 bond to obtain General Fund benefits. Topics covered will include Technology for 21st Century Education as well as cost-savings through energy management and solar power. The goal of the panel will be to try to give the audience information they haven't heard before by focusing on the most current themes being applied by community college districts to be successful in the current political and economic climate.
17	Resources Available Through Department of Energy Grants	When the local Sacramento Municipal Utility District (SMUD) was awarded a \$127 million dollar grant by the DOE to implement Smart Grid technologies one of the 30 projects they pursued was with the Los Rios Community College District (LRCCD). LRCCD collaborated with Honeywell to develop proposals and budgets for submission to SMUD for the DOE grant. Learn how they are using smart grid technology to reduce their energy bill by 15%. Hear about incentives available through the utilities. Learn about the distributed architecture used to handle the 4 campuses and several outreach centers.
18	TRAINING A GREEN WORKFORCE & IMPROVING STEM EDUCATION	The Department of Engineering, Math and Technology and the Department of Career Technical Education are using experiential learning approaches in their classrooms by collaborating with Merced College Facilities Department to use campus facilities as a Sustainability Learning Laboratory. Learn how Merced College is improving the campus environmental stewardship, developing career-ready students through Sustainability Interns and enhancing curriculum to improve STEM (Science, Technology, Engineering & Math) learning outcomes – all while reducing costs for the campus.

20	<p>GASBâ€™s 2012 Surprise UPDATES: A New OPEB 43 and 45 Reporting Standards. Impact on Financial Reporting and Past Service Liability Catch Up</p>	<p>In June 2011, GASB approved two Exposure Drafts that propose changes to how state and local governments report and account for funded pension programs and next to be impacted retiree other post employee benefits (OPEB) provided to eligible employees through a Trust. While the two Exposure Drafts deal with pensions, GASB has on its project list a goal of issuing amended new OPEB standards in December of 2012. GASB watchers not only expect follow-on Exposure Drafts for unfunded non-trust pension plans, but, also, the OPEB Exposure Drafts planned for December of 2012 will incorporate similar changes. The proposed new GASB OPEB guidelines will have an impact on a number of important issues related to actuarial calculations, accounting entries, disclosure requirements, the selection or modification of a Trust etc. The good news is that there are likely to be several years to prepare and strategize for what is coming for GASB OPEB plans. By looking at the new pension Exposure Drafts, it's possible to predict the broad confines and, for some issues, the details of what is likely to happen for GASB OPEB.</p>
