These pitfalls include: violating student privacy laws; inappropriately airing criticism; accidentally exposing private accounts to students/parents/community members; violating policies against sexual harassment and fraternization with students; and the danger of attributing private speech by public officials to them acting in their official capacities as faculty, administrators, and trustees. We will examine various types of social media (Facebook, Instagram, LinkedIn, etc.) and discuss related legal issues which may arise in the educational work setting, such as free speech, intellectual property, and the Brown Act. Learn how to train your employees about the proper use of social media and how to respond to inappropriate conduct by employees, trustees and students which occurs through social media.

What should we do when an outside entity uses a student group to make a point? Some of our students are clamoring for us to create sanctuary campuses and safe spaces on the campus. How far can we go? How can we support students who feel threatened and yet allow

others freedom of expression? This panel will address some of these difficult issues from social, legal, risk and student-centered perspectives.
