2:15pm **Emerging from the COVID-19 Pandemic: What Campus May Look Like in the Fall and What Districts Should Do to Prepare**

Description: The COVID-19 pandemic is having an immense and wide-ranging impact on community college districts, their employees, and their students. Even as life returns to some semblance of normal, districts will continue to navigate new and complex issues related to the pandemic, including what the Fall semester might look like. In planning for the Fall, districts will need to consider federal, state, and local orders, guidance, and legal obligations and many other variables to decide how best to continue educating their students while promoting safe and healthy campuses and offices for employees, students, and families alike.

In this presentation we will discuss some of the critical issues community college districts face as a result of the pandemic, including:

- Legal obligations for maintaining a safe campus.
- Avoiding costly wage and hour mistakes involving telecommuting, reimbursement and off-the-clock working.
- How to effectively manage requests for leaves and accommodations.
- Issues surrounding vaccination policies, exemptions from vaccination requirements, and accommodating employees and students who refuse vaccinations.
