- Simplify, Simplify, Simplify.





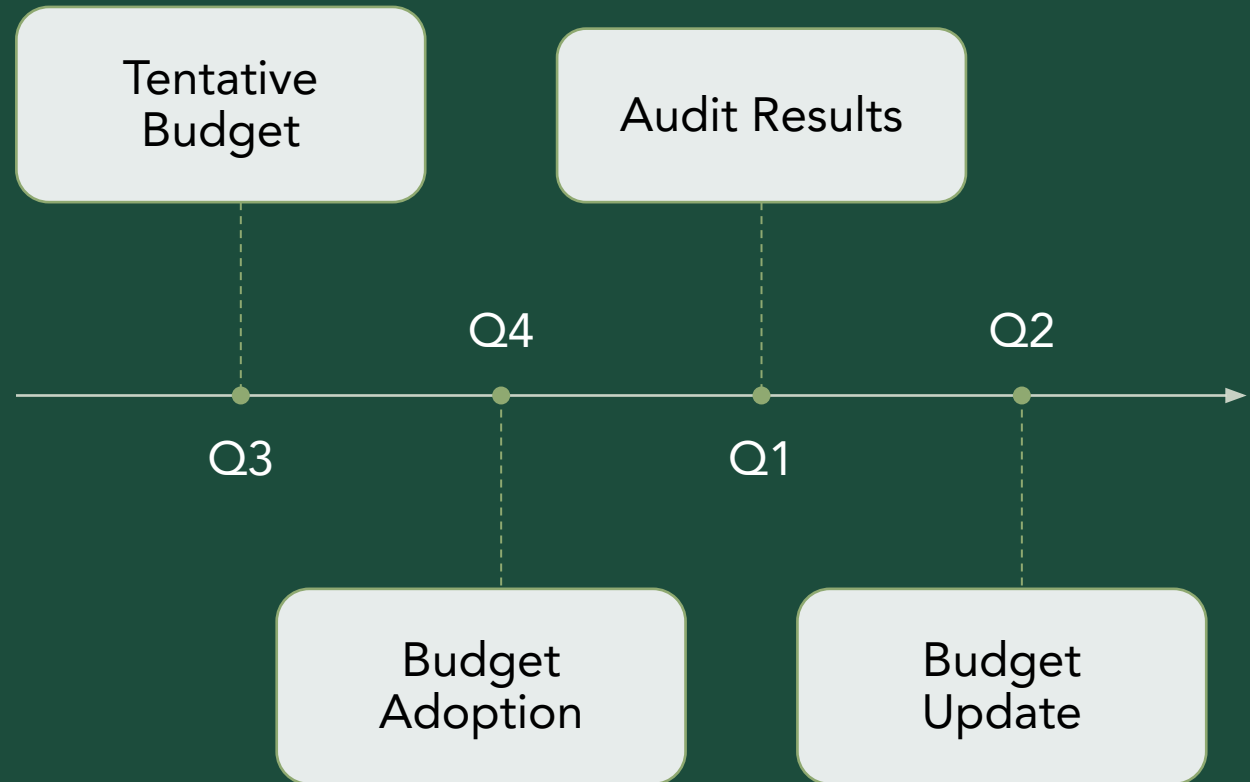

Board Presentations

- Teach Trustees the “Cycle” so they know what to expect during a year
- Advance briefings to preempt in meeting questions
- Use simple short language and simple charts and graphs
- Present good news and bad news
 - Build trust
- Problems with solutions and options

The Trustee and the Annual Audit

- Recognize the Audit Results Are A Trustee Fiduciary Responsibility and have political implications
- Budget and Audit Subcommittee
- Explain the process and trustee role
- Share findings with plans to resolve
- Promise and deliver follow-up on findings
- If necessary, have a communication plan ready

Trustees Role with Policy and Legislation

- Explain Board Policies on Fiscal Matters
 - Reserves
- Create roles, opportunities and activities for Trustees with legislation
- Provide ammunition for advocacy
 - Numbers, facts, impacts



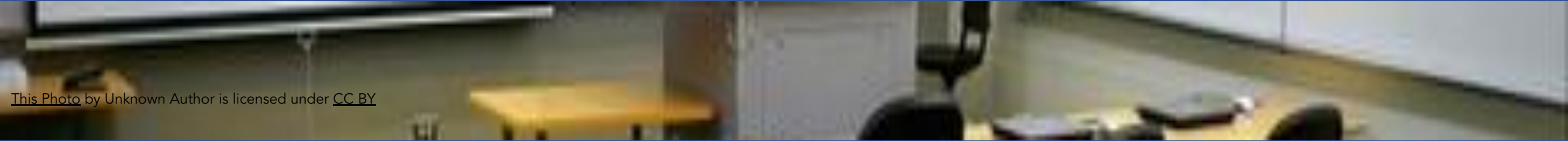
