- America's oldest public community college
- Founded 1901
- Experimental postgraduate high school program

## Chaffey College



Claims to have held first classes in 1883; however, is not recognized as the oldest college in California because classes have not been held continuously.

### Fresno City College

- Founded in 1910
- First public junior college in California
- Not initially established as a separate district



# Junior College Act - 1917

- To provide financial support
- Enlarge mission
  - Mechanical and Industrial Arts
  - Household economy
  - Agriculture
  - Civic Education
  - Commerce
- Citrus College opens 1915



## Junior College Districts

- Authorized by legislature in 1921
- Under State Board of Education
- Modesto Junior College 1st J.C. District



#### California in the 1940s

- In 1947 population reached 10 million
- Junior College enrollments up to 107,000
- Offerings expanded for returning G.I.s
- El Camino College opens 1946



### California Community Colleges in the 1960s

- Population reached 16 million
- Junior College enrollments up to 340,000
- Grossmont College opened in 1961



# Master Plan for Higher Education

- High quality, accessible, affordable
- U.C. top 1/8
- C.S.U. top 1/3
- Community Colleges open door
- Victor Valley College opens 1961



#### **Board of Governors**

- Created in 1967
- Removed community colleges from SBE
- Does not follow CSU model
- Strong support for local control
- DeAnza College opens 1967





#### California in the 1970's

- Population grows to 23 million
- Becoming more diverse
- CC enrollments double to 1.3 million 104 colleges, 70 districts in 1975
- Three Major Influences on CCC
  - Revenue Limits
  - Collective Bargaining
  - Proposition 13
- Oxnard College opened in 1975



#### California in the 1980's

- Population grows to 30 million
- Economy struggles; fees imposed
- Many voices little consensus
  - Revenue per ADA down
  - Eliminated recreational courses
  - State could not fund Capital Outlay needs
- More details in statutes
- IVC 1986



# The Review of the Master Plan 1986-88

- Results in AB 1725
- Validates mission
- Recognizes system
- Collegial Consultation
- 1988 Las Positas College



#### CCCs in the 1990s

- Proposition 98
  - Minimum Revenue Guarantee
  - Program Based Funding
- Proposition 111 Allowed for a lower minimum guarantee
- Differential Fee for BA Holders



# Community Colleges in the United States Today

- 12.3 million credit students
- 45% of all U.S. undergraduates
- 1,166 community colleges
- Average tuition (2016) \$3,340 annually
- Over 600 Boards of Trustees
- 6,500 Board members

#### National Student Profile

- 52% of all African American students in higher education
- 57% of all Hispanic students
- 43% of all Asian/Pacific Islander students
- 55% of all Native American students
- 41% of first time freshmen
- 57% female; 43% male
- 64% part-time; 36% full-time
- Average student age is 29



#### California Community Colleges Today

- Largest system of higher education in the world
- 113 colleges in 72 districts
- 2.1 million students
- Lowest tuition in the U.S.
- Among the most diverse systems of education in the world
- Uniquely successful experiment in higher education for the masses

#### **Board of Governors**

- 16 member board appointed by the Governor
  - 1 designated as a local trustee
  - 2 community college faculty
  - 1 student trustee
- Provides policy and direction for the system
- Selects the Chancellor
- Directed to maintain and continue, to the maximum degree permissable, local autonomy and control of the CCs




#### Major System Issues in Year 2017
