

**Bonnie Ann Dowd, Ed. D., MBA, CMA, Executive Vice Chancellor, Business and Technology Services  
San Diego Community College District (SDCCD)**

Bonnie began her career in the California Community College System as an adjunct faculty member teaching in the Business Education Department at Palomar College. A year later she accepted a tenure track faculty position, which she served in for nearly 17 years. In addition to her classroom work at Palomar, Bonnie served in numerous faculty leadership positions, including Academic Senate President, Senate Secretary, Academic Technology Coordinator, Professional Development Coordinator and Business Education department chair. During her final 6 years at Palomar, Dr. Dowd was the Vice President, Finance and Administrative Services responsible for all business, facilities, fiscal and technology operations. Prior to leaving Palomar to accept her current position at SDCCD, Bonnie was granted Professor Emeritus status by Palomar's Academic Senate. In her current position at SDCCD, what distinguishes her from other vice chancellors is that when the Chancellor is away from the District she is the Acting Chancellor. Prior to her career in education, which began 33 years ago, Bonnie worked in private industry in various closely-held and publicly traded corporations in New York City, Houston and San Diego.

Dr. Dowd possesses an Ed. D. in Leadership Studies from the University of San Diego, an MBA in Financial Management, a BBA in Accounting, and an AAS in Business. All of her education was completed as a part-time student while working full-time over 20 years. She is a licensed Certified Management Accountant (CMA), holds a Lifetime Community College Teaching Credential in several areas of instruction; and, earned a Distance Education Coordinator certification from California Virtual Campus Statewide Rural Regional Center (CVC4) and the Covey Institute.

At the California Community College system level, Bonnie serves on several boards, associations and workgroups. She is the current Immediate Past President of ACCCA (Association of California Community College Administrators) and in her eleventh year as a Director on the ACCCA Board, which represents all system administrators throughout the 73 district/116 college system. Bonnie also serves on the Board of Directors of the Association of Chief Business Officials (ACBO), representing the ten community colleges, located in San Diego and Imperial Valley counties. Bonnie is in her sixteenth year on the ACBO Board and is a past president. She currently chairs the System Chancellor's *Advisory Workgroup on Fiscal Affairs* which is an advisory workgroup on matters impacting all 116 community colleges. Dr. Dowd was appointed by the State Chancellor to represent all San Diego County community colleges on the County of San Diego Oversight Board of the successor agencies for the former redevelopment agencies. She was recently appointed to the County of San Diego's Treasurer's Investment Oversight committee. California Senate Pro Tem Toni Atkins appointed Bonnie to the twelve- member Student Centered Funding Formula (SCFF) Legislative Oversight Committee. She is in her seventh year teaching in the San Diego State University's Doctoral Program in Leadership. She also serves on local boards and was a volunteer counselor with the U.S. Small Business Administration through its ACE/SCORE program and was president and Board Member of the Southern California Women for Business Ownership.
