



**Dr. Bonnie Ann Dowd**, Retired January 31, 2023 after 35 years of experience in the California Community College system. Final 12 years at San Diego Community College District (Multi-college district) where she served as the Executive Vice Chancellor, Business and Technology Services. Prior 23 years were at Palomar Community College District (Single-college district) as Assistant Superintendent/Vice President, Finance & Administrative Services/Professor Emerita, Business Education. Prior to her community college career, Dr. Dowd worked in private industry for 20 years in publicly traded corporations and various closely held businesses in New York City, Houston, and San Diego.

Bonnie began her career in the California Community College system at Palomar CCD as an adjunct faculty member teaching various accounting and general business classes. After one year as an adjunct, she was hired into a tenure track full-time faculty position in the Business Education department. Classes taught included various levels of accounting, advertising, marketing, and small business management in traditional classrooms, ETV, and on-line modalities. During her 17 years as a faculty member, she served in various faculty leadership positions, including Academic Senate President, Senate Secretary, Academic Technology Coordinator, Professional Development Coordinator and Business Education department chair. During her final 6 years at Palomar, she was the Vice President, Finance and Administrative Services ending her career at Palomar having been awarded Professor Emerita status by the Academic Senate. Upon her departure from Palomar, she joined SDCCD as the Executive Vice Chancellor, Business and Technology Services overseeing all business, finance, and technology operations for the four-college district. As Executive Vice Chancellor, Bonnie served as the district Chancellor when the Chancellor was unavailable.

Prior to her educational career, Dr. Dowd worked in private industry in various closely held and publicly traded corporations including New York Life Insurance, Columbia Broadcasting Systems (CBS), E.F. Hutton, Executive Air Services, and Critical Air Medicine.

Bonnie earned an Ed. D. in Leadership Studies from the University of San Diego, an MBA in Financial Management, a BBA in Accounting, and an AAS in Business. All of her education was completed as a part-time student while working full-time over a span of 20 years. She is a licensed Certified Management Accountant (CMA), holds a Lifetime Community College Teaching Credential in several areas of instruction; and earned a Distance Education Coordinator certification from the California Virtual Campus Statewide Rural Regional Center (CVC4).

At the California Community College system level, Bonnie served on the Board of Directors for the Association of Chief Business Officials (ACBO) representing all 73 community college districts, 116 colleges in the California Community College system with regard to business and financial matters. Her service on the ACBO Board spanned fifteen consecutive years including as ACBO's President. Bonnie also served on the Board of the Association of California Community College Administrators (ACCCA) for six consecutive years as member of its Board of Directors and as its President. California Community College system chancellors appointed her to represent all San Diego community colleges on several County and City of San Diego and state Oversight Boards. The California State Senate Pro-Tempo appointed her as a member of an oversight committee convened to improve upon state funding for all community colleges. During her San Diego business career, Dr. Dowd

volunteered as a counselor for the U.S. Small Business Administration's ACE program and on the Board and as President of the Southern California Women for Business Ownership organization in support of San Diego County's closely held entrepreneurial businesses. She also taught as an adjunct professor/lecturer for ten years through 2024 in San Diego State University's School of Education's Leadership doctoral program.
